Special Terms and Conditions for Christmas, New Year and Epiphany
Booking period 22.12.2021 - 8.1.2022

CONFIRMATION

Credit card details are collected to confirm bookings. When 5 or more rooms are booked, the reservation is considered confirmed upon the receipt of the 20% non-refundable deposit. Services ordered on site are to be paid full prior to departure. Proforma invoices will be issued for each payment and payments are requested to be submitted by wire transfer to Hotel Santa Claus Ltd bank account. Alternatively, accommodation and services can be paid with credit card.

PAYMENT SCHEDULE

All deposit must be settled according to the following schedule. All deposits are non-refundable. 100% of the total amount to be in our account by 31.10.2021 for all bookings. All invoiced deposits to be in account by 14 days prior group arrival.

Hotel Santa Claus Oy (Ltd) reserves the right to release, without any further notice, all rooms not guaranteed with full prepayment deposit and with full rooming list with passport numbers by demanded due date.

CANCELLATION POLICY

If the confirmed reservation is cancelled, the following terms will apply:

Cancellations before 31.10.2021	without charge
All cancellations on 31.10.2021 or later	100% charge

Note: All documents, changes and cancellations to bookings must be made in writing, i.e. by e-mail, within the office hours in Finland. Any notices received outside of the Working Days and office hours of 9.00 am and 5.00 pm shall be deemed made on the next Working Day. All notices must be acknowledged by Santa's Hotels.

SETTLEMENT OF DISPUTES AND DISCORDS

The laws of Finland govern the contract between Hotel Santa Claus Oy (Ltd) and the buyer. All disputes and discords, which may arise, shall be subject to settlement by arbitration. Arbitration shall be held in the City of Rovaniemi under the rules and regulations of arbitration in Finland.
